NATIONAL AFFAIRS

1. PM Modi Inaugurates and Lays Foundation Stone for Projects Worth ?1,220 Crore in Gujarat's Ekta Nagar.



Prime Minister Narendra Modi visited Ekta Nagar (formerly Kevadia) in Gujarat to inaugurate and lay the foundation stone for development projects worth ?1,220 crore. The projects span sectors like tourism, infrastructure, and urban planning, aimed at transforming the area around the Statue of Unity into a major global tourist and development hub.

2. Cabinet Approves Nutrient Based Subsidy (NBS) for P&K Fertilizers for Rabi 2025-26.



The Union Cabinet approved the Nutrient Based Subsidy (NBS) rates for Phosphatic and Potassic (P&K) fertilizers for the Rabi 2025-26 season (October–March). This approval involves a subsidy of ?37,952 crore and aims to insulate farmers against the rise in global soil nutrient prices, ensuring the availability of non-urea fertilizers at affordable rates.

- The Union Cabinet approved the Nutrient Based Subsidy (NBS) rates.
- The subsidy is for Phosphatic and Potassic (P&K) fertilizers for the Rabi 2025-26 season.
- The total tentative budgetary requirement for the subsidy is estimated at ?37,952 crore.

It promotes the balanced use of fertilizers (N, P, K, S).


Prices of non-urea soil nutrients like DAP

3. Cabinet Approves Formation of 8th Central Pay Commission (CPC).



The Union Cabinet approved the Terms of Reference (ToR) for the 8th Central Pay Commission (CPC). The commission will revise salaries and pensions for nearly 5 million Central Government employees and 6.9 million pensioners. The new pay and pension hikes are expected to be implemented retrospectively from January 1, 2026.

- The commission is set to revise salaries and pensions for nearly 5 million Central Government employees.
- The recommendations are expected to be implemented with retrospective effect from January 1, 2026.
- The commission will be headed by former Supreme Court judge Ranjana Prakash Desai.

INTERNATIONAL

1. 104 Casualties Reported in Gaza Following Israeli Airstrikes.



Following intensified military operations, reports indicate that at least 104 people were killed in various locations across Gaza due to continuous Israeli airstrikes. The casualty figures include women and children, highlighting the severe humanitarian crisis and the widespread destruction of civilian infrastructure in the besieged territory.

2. China Files WTO Complaint Against India's PLI Schemes Over Domestic Value Addition (DVA).



China has formally lodged a complaint with the World Trade Organization (WTO) against three of India's Production Linked Incentive (PLI) schemes, particularly those related to electric vehicles and batteries. China claims that the schemes' requirements for Domestic Value Addition (DVA) violate key WTO rules on national treatment and trade-related investment measures (TRIMs).

- China filed a complaint with the World Trade Organization (WTO).

1. RBI Grants Exemption to SWAMIH Fund for Stalled Real Estate Projects.



The Reserve Bank of India (RBI) granted regulatory exemption to the Special Window for Affordable and Mid-Income Housing (SWAMIH) Fund for funding stalled real estate projects. The exemption allows the fund to operate with greater flexibility and expedite the completion of pending affordable and mid-income housing projects, protecting the interests of homebuyers.
